Mr. Glency advised that there is another house that the Fire Department would like to do a live burn for training. Discussion was then heard on the City's liability for live burns. Eric Seyer recommended turning this over to the Fire Committee to look into and bring back to the Council.

Emergency Preparedness- the Mayor the advised that the Emergency Preparedness vehicle is coming along.

Water Deposit and Reconnect fees. The City Administrator recommended raising the Water Deposit fees to \$75.00 for Homeowners and \$125.00 for Renters. The Administrator recommended the following

Reconnection Fee Schedule:

\$25.00 First time water is shut off

\$50.00 Second time water is shut off

\$75.00 Third time water is shut off

\$100.00 Fourth time water is shut off

\$125.00 Fifth time water is shut off

The fee will go back to \$25.00 if a 12 month period has been completed and there have been no shutoffs.

Motion by Ron Davis to approve the City Administrators recommendation for the Water Deposit Fees and the Reconnect Fee Schedule, seconded by Darlene Crocker. Motion Carried.

The City Administrator advised that the CUSI, the current water billing software provider offers a customer web portal that links to our software and allows payments online as well as customer ability to view account history and make customer service requests. The cost is nothing for the City but customers will be charged a \$2.95 convenience fee (paid to CUSI) or 3% for bills over \$100.00. The City Administrator asked about partnering with CUSI and implementing the payment portal. Motion by Eric Seyer to allow the online pay, seconded by Ann Whistler. Motion Carried with one no.

The City Administrator advised that the next Council Meeting is on September 5th Labor Day and recommended moving the Council Meeting to Tuesday, September 6th. Motion by Eric Seyer to change the next Council Meeting to September 6th seconded by Darlene Crocker. Motion Carried.

The City Attorney advised that the decision of the Building Commissioner is still in the appeal period for demolishing the old hospital building.

The Mayor recommended that the Building commissioners Salary be increased to \$50.00 for a minimum of one hour and over one hour would be \$10.00 per hour.
