The City Administrator advised that the City has received a permit from DNR for the sewer extension construction and a list from USDA of items needed to take the project to bidding. Schultz Engineering has sent a letter with invoices totaling \$50,032.50 dating back to May 2016 for work they have done on the project but have not invoiced. They are not asking the City to pay it all but anything the City can do would be appreciated. The money is in the sewer project budget to be covered by the USDA Loan. The City Administrator advised that there are four things the city can do:

- 1. Nothing
- 2. Pay a portion. 1/5 would be \$10,000.00
- 3. The City has a an open active line of credit with the Bank of Advance
- 4. Pay out in payments
