Fire Department-The Mayor advised of some requests from the Fire Chief who was not present. (1) Fire Chief, Sam Glency asked for permission to enter a lease with Airgas in Cape Girardeau. He advised that the Fire Department needs to increase their cascade system to 6000 psi 4 bottle systems. To purchase the 4-6000 psi bottles the cost would be about \$10,000.00 and the fire department would be responsible for maintenance and static testing every 5 years. He advised that if the Fire Department can lease the bottles on a 5 year lease the initial cost for 4 bottles with be \$350.00 each for a total of \$1,400.00 and \$200.00 each for a total of \$800.00 for each additional 5 year renewal and they take care
