The City Administrator advised that the Housing Agreement with the Humane Society of Southeast Missouri will be increasing from \$10,866.00 to \$16,932.00 for 2020 and \$23,000.00 in 2021. He said instead of taking the dogs to the Humane Society, an option would be to keep them for a longer period of time and work with Dr. Shively in Scott City to try to adopt them out. Unsuccessful adoption after a period of time would require the City to consider the vet euthanizing the animals. He attached the rates for services from Dr. Shively regarding animal control. Discussion was then heard. Motion by Ann Whistler to have the City Attorney prepare an Ordinance to enter into an agreement with Dr. Shively, seconded by Ronald Eichhorn. Motion Carried.

The City Administrator advised of two trees needing to be taken down at 130 Gray and 316 Yoakum. A bid was received from Twin Cedars Tree Service at \$875.00 to take both trees down. Motion by Ronald
