City Attorney, David Summers advised that he is retiring at the end of the month.

Randy Dooley asked the Council to make a policy that no person be denied employment by the City of Chaffee based upon vaccination status. Randy Dooley made a motion that the city develop a policy that no person will be denied employment by the City of Chaffee based upon vaccination status for any vaccine. Furthermore, that the continued employment with the City of Chaffee will not be based upon the vaccination status for any vaccine and that methods of coercion, intimidation, retaliation, and bullying by any person whether employed by the city or elected to an office to get a person to be vaccinated will not be tolerated and if such behavior is proven to be true that person shall be brought before the council for consideration of penalty, seconded by Ron Davis.
