The meeting was opened by the Mayor, Steve Loucks.

Pledge of Allegiance was led by Eric Seyer.

The minutes of the previous meeting were read by City Clerk. A motion made to approve the minutes with corrections, made by Eric Seyer, seconded by Ron Davis. All in favor. Motion Carried.

The Police Chief Sullivan reported that they are getting prepared for the upcoming bad weather by testing the generator for the nutrition center since it will be a warming center.
