

# Regular Council Meeting

The meeting was opened by Mayor, Steve Loucks.

Mayor Steve Loucks stated that the Police Department is in charge of handling such issues. The City of Chaffee, MO Dangerous Dogs Animal Regulations were presented and discussion was heard. Police Chief, Billy Sullivan stated that all reports made to the Police Department are being handled with proper notices and citations.
