The meeting was opened by the Mayor, Steve Loucks.

Pledge of Allegiance was led by Eric Seyer.

The minutes of the previous meeting were read by the Assistant City Clerk. A motion made to approve the minutes by Ron Davis and seconded by Darla Britain. All in favor. Motion Carried.
