Regular Council Meeting

The meeting was opened by the Mayor, Steve Loucks.

The Pledge of Allegiance was led by Eric Seyer.

The minutes of the previous meeting were read by the City Clerk. A motion made to approve the minutes by Steve Milz and seconded by Danny Finley. All present in favor. Motion Carried.

Fence and building permits were presented for; David Pepple at 606 Robin Hood Circle for a new garage, Angie Ruiz at 601 S. Main St. for a portable storage building, Travis Keys at 342 E. Fire Chief Glency let the Council know that the Medical Director for North Scott County Ambulance retired and the medical protocols have changed under their new leadership. Our 1st Responders can no longer run under North Scott County protocols. Sam is working with the Gordonville Fire Department and a St. Francis E.R. Doctor in order to have new protocols written and the ability to have them signed off on by the Medical Director. This year the cost of these changes is estimated at \$1000.00 and can be covered by the 1st Responder budget. Sam will keep the Council updated. Discussion was heard.

Andy Sadler updated the Council for the Park Department.

The Park Board raised the rate for the family pass to \$160.00.

Frisco middle has run out of storage room and needs either another storage building or a larger building and they are expecting the cost to be \$3,000.00 to \$5,000.00.

Poles still need to be replaced and one has fallen. Rusty Golightly has free poles but someone is needed to set them.

Internet access at the fields has been discussed and quotes are being gotten.

The aerator for the pond will need electricity; there may be a meter base close that will be checked into. Repair or replacement of blown off shingles is needed at Middle field.

Keith Glaus is working on the security window at Middle field.

Semo Rampage is hosting a tournament July 11th through 13th to benefit the Missouri Veteran's Home in Cape Girardeau. The Park Board would like the City to waive the field rental fees for this tournament. Jake Williams has delivered the fish to the pond.
